1. Background

Conservation International (CI) has been protecting nature for the benefit of all, for over 30 years. Through science, policy, and partnerships, CI is helping build a healthier, more prosperous, and more productive planet. Today, with offices in more than two dozen countries and a worldwide network of thousands of partners, CI has a truly global reach.

Conservation International is one of the three executing partners of the Towards Ending Drought Emergencies (TWENDE): Ecosystem Based Adaptation in Kenya's Arid and Semi-Arid Rangelands. The 5- year TWENDE project is funded by Green Climate Fund (GCF), with IUCN as the accredited entity.

The objective of the TWENDE project is to reduce the cost of climate change induced drought on Kenya's national economy by increasing resilience of the livestock and other land use sectors in restored and effectively governed rangeland ecosystems. The project contributes towards Kenya's national policy of "Ending Drought Emergencies", as outlined in "Kenya Vision 2030". It strengthens climate change adaptation in Kenya's arid and semi-arid lands (ASALs).

2. Project Overview

The project is implemented in three landscapes (Sabarwawa, Mid Tana and Chyulu Hills) spanning 11 counties. These target landscapes face a range of challenges including weak capacity for landscape planning, poor access to climate data and analysis, and limited access to markets and financial services. Implementation of the TWENDE project is through three components:

Component 1: Climate change adapted planning for drought resilience – The component ensures coordinated transboundary rangeland management decisions are strengthened by enhanced climate change analysis and participatory community and county planning. The component contributes to addressing the barriers of weak capabilities and inadequate governance institutions. National Drought Management Authority (NDMA) is the executing entity for this component.

Component 2: Restoration of rangeland landscapes for ecosystem-based adaptation — The components main output is to ensure prioritized rangeland resources (including water), are brought under restoration, safeguarded and sustainably managed for improved climate change resilience. Ministry of Agriculture, Livestock and Fisheries is the executing entity for this component.

Component 3: Climate change resilient ecosystem management for investments – Main focus is public, private and community investments in natural resources, addressing barriers related to

insufficient investment in rangelands and poor access to markets and financial services. Conservation International is the executing entity for component 3.

Component 3 Overview

Component 3 of the TWENDE project is made up of four activities as follows;

- Activity 3.1: Climate resilient Investment in priority value chain that have been validated by local communities,
- Activity 3.2: Provide grants to establish restoration enterprises created/led primarily by
- women's groups,
- Activity 3.3: Establish financial incentive mechanisms for sustainable land management,
- Activity 3.4: Provide grants to community-based enterprises for ecosystem-based adaptation that could create opportunities for investments in the value chain.

Each of these activities is co-implemented with service providers including: KEFRI (activity 3.1) Just Digit (activity 3.2), IUCN Kenya (activity 3.3) and CI Ventures for activity 3.4. A number of field implementing partners have been brought on board including Northern Rangelands Trust (NRT) and Maasai Wilderness Conservation Trust (MWCT), Biglife Foundation and Anglican Development Services Eastern among others.

Activity 3.1 seeks to analyze prioritized value chain: camel milk, honey, fodder/grass seed and meat value chains to verify and quantify the opportunities, identify systemic bottlenecks and develop actionable business cases with an intervention plan for each of these value chain. Already, robust business plans have been developed. This phase of assignment intends to support the target enterprises implement the business plans to unlock investment and catalyze their growth and thus enhance climate resilience for the communities and the landscapes.

3. Terms of Reference, Deliverables and Deliverables Schedule

3.1. Purpose

Conservation International now wishes to engage consultants for a **6-month period** to undertake support for camel milk value chain business cases implementation. The proposed assignment supports community enterprises implement business plans developed through a previous phase of assignment. The business plans clearly outlined the capacity gaps that needed to be addressed to unlock growth for the enterprises. This phase of assignment will address those needs as outlined in the business plans.

The purpose of this consultancy is to support these rangeland enterprises to roll out execution plans, undertaking to develop strategies, tactics and models that will work where and why, quantifying envisaged costs and benefits as well as projected growth trajectories. The consultants are also expected to support the enterprises to develop tools for measuring business performance by setting up key indicators capable of evaluating the extent to which the desired restoration, food security, environmental, socio-economic and climate resilience impact will be enumerated. This support that will include application of appropriate technical skills, acquisition of material and equipment, access to allowable capital and operational capital as well as well conformity to policy and regulatory standards

will eventually be expected to facilitate the enterprises to develop sustainable businesses capable of attracting further financing and investment.

The assignment will complement and closely align with other on-going TWENDE project activities. Under activity 3.3, a Community Resilience Facility (CRF) is under development to avail micro-credit to communities. Under activity 3.4, the target enterprises will be receiving in-kind grants to acquire core assets they require to unlock growth. The consultants will provide critical information and support to these two activities including being part of the appraisal processes.

3.2. Specific objectives

- i. Undertake a comprehensive review of already developed business plans for each of the enterprises in camel milk value chain and evaluate investment requirements, quantifying specific value of material, equipment and allowable capital and operational expenditures required to grow their enterprises.
- ii. Review, design and refine the technical assistance required by the enterprises to access and effectively utilize Impact Finance facilities.
- iii. Review and build the capacity of the enterprises in order to conform to policy and regulatory standards in their value chain in order to align their products to these requirements for sustainable market development and increased drought resilience.
- iv. Carry out financial appraisals of the enterprises and their business plans and create awareness on the Small Grants Facility and loans under the CRF
- v. Appraise the environmental, social and financial risks that exist in each enterprise and support them in preparing risk management plans.
- vi. Roll out short- and long-term growth and customer acquisition plans accompanied by financial forecasts.
- vii. Support the enterprises in preparing and aligning their Business Pitch Deck to the Small Grants and CRF that will articulate the story of the company in its best light that fully demonstrates their growth potential and value if supported under the Impact Finance facility.
- viii. Provide oversight and technical support to ensure equipment provided by the small grants facility is of the right specification. Additionally, the consultants will ensure the procured assets have been installed and are in use.

3.3 . Methodology and approach

The consultant will identify and describe the most appropriate and efficient methodology and approach to be undertaken in supporting the enterprises to access Impact Finance in the implementation and execution of their new business plans. Additionally, the consultant will design the most effective approach in the acquisition and utilization of appropriate technical, material and allowable capital and operational expenditures.

It is envisioned that the methodology will include (but not limited to) the following:

i.Refinement of the assignment methodology and approach

- ii.Quantification of material, equipment, capital and operational expenditures required by the restoration enterprises and how these can be supported by the Impact Finance
- iii.Formulation of Key Performance Indicators to be used to quantify impact on socio-economic, environmental, restoration and food security aspects
- iv.Providing technical assistance, awareness and capacity development for each of the enterprises to align them to the Small Grants and Community Resilient Facilities
- v.Ensure support provided by CRF and small grants facility is in use.

3.4. Deliverables/Outputs of the Assignment

Three main deliverables are expected:

- i. **Inception Report:** In the project inception phase, the consultant will undertake consultation with CI TWENDE project team and service providers to ensure that a holistic assignment methodology and approach is developed. Within 14 days from the commencement of the assignment, the consultant will submit to CI an inception report that details the assignment methodology and delivery timelines.
- ii. **Monthly Assignment Update Reports**: The consultant will submit 4 monthly update reports to CI. The update reports will provide a summary of progress in respective business case against agreed upon KPIs. The reports will clearly outline Impact Finance activities that have been undertaken and what stakeholders have been engaged.
- Final report: The consultant will present the final report to TWENDE Team, outlining the rolling and implementation activities related to access to Impact Finance and their appropriate alignment to their revised business plans.

4. Submission Details

5. Minimum Requirements

The consultants are expected to work independently with CI and provide technical support camel milk value chain business cases in accessing and utilization of Impact Finance based on their revised business plans. The consultants — will meet the following key skills, experience and qualifications.

- a. Minimum of ten (10) years of experience in socio-economic, climate change resilience, restoration enterprises, rural economic development, markets and enterprises development, value chain development, and natural resource management.
- b. Practical experience in working on a range of climate change adaptation and restoration issues in the Kenyan rangelands with a focus on environmental impact innovations and capacity to work with small rural Enterprises.
- c. Strong experience and networks in camel milk value chain as well as other agricultural value chains.
- d. Conducted agribusiness development programs in ASAL within East African region.
- e. At least ten (10) years' demonstrated agribusiness development services experience for large development projects
- f. Previous experience in the development of investable enterprises, experience in value chain development, innovative market system and incentive payment schemes.
- g. Strong stakeholder engagement skills and demonstrated good thorough knowledge of the Rangelands' ecosystem in Kenya and beyond.
- h. Proven experience in applying gender lenses in rural enterprises development.
- i. Clear understanding of marketing and enterprises development methodologies and experience using a range of tools and techniques with regards to rural enterprises.
- j. Fluent in spoken and written English and Swahili.
